In addition, Section 5, CISI By-Law #1 1953 directed that, "Those persons voted to Honorary Membership prior to the passing of these by-laws be recognized under the appropriate section of these revised by-laws." Thus Regular and Retired Members awarded **Honorary Membership** up to 1953 have been changed to **Life Membership**.
