# **Operation Esperanza, Ecuador**

At the end of January 2019 myself, my husband Tom, who is a dentist and my 14 year old son Liam had the privilege of being part of a medical/ dental mission entitled "Operation Esperanza" in Ecuador. In English, this means "Operation Hope". The local Rotary Club in Cuenca, Ecuador, organizes this mission at ground level where every year through a local physician finds residents in the City and in the surrounding countryside who are in need of knee and hip replacements. A Canadian team of orthopedic surgeons, nurses, anesthesiologists, physiotherapists, dential assistants, dental hygienists and a host of volunteers travel to Ecuador with over 40 large size duffle bags with medical and dental equipment.

This was our first year attending and our expectations were mixed, but we quickly realized how special this mission was and how important our work was to the Ecuadorian people.

As a health inspector, I found my training in infection control quite useful. I was responsible for the cleaning and sterilizing of all the dental equipment. This was quite an experience as we were a travelling unit and had to start up and shut down every two to three days.

I was using a cold sterilant to soak the tools, and manually scrubbed all the tools prior to rinsing and then sorting for autoclaving. Due to the number of patients we were seeing every hour, I could not bag the equipment for sterilization, but rather sterilized un-bagged. Although this process of not bagging the tools individually is not acceptable practice in our country, it was acceptable by the Ministry of Health in Ecuador. This was the second year that this group had an autoclave and in the past cold sterilant was solely used.

Once the tools were sterilized, I would glove and handle the sterilized items carefully not handling the business ends to keep the item as clean as possible, and bag them into procedure bags. Dentists use a lot of equipment for one procedure and I had to quickly learn what tools went where. Due to lack of plumbing at our satellite locations hand sanitizer was used between gloving.

We also were a travelling dental office so we would be doing dentistry where we could get the space. For the school we visited we had one classroom to fit in three dentists, two hygienist, portable x-ray and the cleaning and sterilizing area. Also with all of our equipment, we had to rely on the school for tables and chairs. The doctors sat on patio chairs and we mustered up desks and random tables to set up a cleaning and sterilization area and storage area for tools and equipment.

We also taught children how to brush their teeth and gave each child their own toothbrush and toothpaste. The

children touched us so much, with their smiles and happy spirit. We spent three

days at the school trying to see as many children as possible.

# Operation Esperanza, Ecuador, cont'd...

On the fourth day we set up our clinic in the basement of the Del Rio University Hospital, where the orthopedic medical team was located and saw all patients who were good candidates for hip or knee replacements. It is important that when someone is getting surgery like a knee or hip replacement that his or her dental hygiene is optimum. Any signs of infection can cause the replacement to fail. Therefore, all patients that were eligible for surgery had to be assessed by the dental team, and that day 60 patients were seen. Those who passed their dental exam and had some dental procedures realized that they would be getting their knee/or hip replaced and I cannot tell you how happy these people were, to the extent that they were thanking us with tears streaming down their cheeks!

From the hospital on the 5<sup>th</sup> day we went to visit a local shelter "a Posada" in Cuenca. The majority of residents who were living in the shelter were Venezuela refugees. We saw young and old, mothers, fathers and children all require some type of dental care. These residents were so thankful for some were living in dental pain for months and years.

My family and I went on this trip to give our help, and took so much more than what we gave. We worked long days but it felt good when we could provide dental service to prevent any further decay and teach the people the basics of dental care and prevention. We met a great group of dental and non-dental volunteers, which we coined affectionately as "team dental". We worked hard as a team, always happy to help each other out with a smile, all day long, and even when the day was over the team continued to speak of the amazing people they met. Although language was a barrier, the act of kindness is one thing that everyone understands.



#### NATIONAL BYLAWS

#### FOR REGULAR MEMBERS:

SECTION II Membership Types 2.01 Class A Members (iv) Regular 1) Persons may be eligible for Regular Membership if they:

- a) Hold the Certificate in Sanitary Inspection (Canada), the Certificate in Public Health Inspection (Canada), or if they possess those qualifications acceptable to a three-fourths vote of the entire board; and
- b) Participate in the continuing professional competency program of the Council of Professional Experience of the Corporation.

#### **DECLARING A REDUCTION IN PROFESSIONAL DEVELOPMENT HOURS**

If you are unable to meet the requirements of the CPC program because you worked part-time; took a leave of absence; were on medical, maternity or paternity leave; or were unemployed during the course of the calendar year you must declare a reduction in Professional Development Hours (PDHs) in the Professional Practice category to be exempt from meeting full PDH requirements.

\*\* Effective March 1st 2019, declarations for a reduction of PDHs is only electronic\*\* Members must now use the new ONLINE CHECKBOX:

#### How Hurricane Dorian Attended The 2019 AEC In Halifax:

I had the honour of attending the National Annual General Conference in Halifax this September and representing our branch. The National Executive Council meets two days prior to the start of the conference to discuss and finalize policy updates, provide subcommittee work, discuss EPHW, review BOC, EHFC and CoPE related items, go over conference details, AGM preparation, awards preparation and address any new business while also planning for future projects.

With Hurricane Dorian predicted to land in Halifax Saturday afternoon, the NEC was on day two of the full day meetings. On Friday night, Nova Scotia officials were advising residents to buy food and supplies in preparation for a blackout. The local No Frills store shelves were bare before closing that night, and it was evident that locals and conference attendees were preparing for the storm. Everyone who was preparing was very calm, very matter of fact. All the non-locals were excited and there was a buzz in the hotel. The boardroom where the NEC meetings were held had a large window where we had previously seen the sun of Friday turn to rain Saturday with strong wind gusts as the afternoon wore on.

By 1pm, visibility had decreased and the air was extremely fresh. By 2pm, 95,000 in Nova Scotia were without power. Wi-fi service no longer worked. By 3pm, it was our turn in Dartmouth: the hotel power went off and we were left with emergency lighting only. Luckily, the wi-fi service was re-activated with the emergency generator. With agenda items still to cover, the NEC meeting continued. When we stopped for a break, we couldn't help but venture outside to see the hurricane force winds for ourselves. From the door, it just looked like a wall of rain coming down misting its way under the large canopy. We had to know more. So we ventured out further and felt the strong winds while we got drenched. The postal mailboxes had already tipped over. The further out we ventured, the more powerful the wind. Some were braver than others, and passed a corner but not for long before coming back completely soaked. Despite the excitement and uncertainty of the tropical storm, the meeting continued and we got through our agenda. The category 1 hurricane was elevated to a category 2, but since we were a little off the coast in Dartmouth, we felt much safer.

As the evening went on, the power remained off, and cell phone and laptop batteries were running low. The front desk became the main charging system with their emergency power supply. The hot water eventually ran out and the hotel room fridges were no longer cold. People were wondering how much longer would we be without power. The power outage had now affected 400,000 in Nova Scotia at the storm's peak.

We also couldn't help but wonder if the conference food was being affected by the power failure but found out that luckily the kitchen had emergency generators running. Our reception foods were now cold foods as well as the breakfast the next day.

On Sunday evening, more delegates arrived at the hotel. The Sunday reception was held somewhat in the dark as the sun set, but conversations were lively as all discussed how the hurricane had affected they travel plans and or their hygiene (no hot showers!). Everyone was hopeful that the power would be restored that evening by 11pm as per the Nova Scotia Power outage website. Attendees were looking out the windows and noticed that Halifax was lit up. And that if we ventured far enough out of the neighbourhood, we could have access to warm meals, hot coffee and a lit up environment. In preparation for day 1 of the conference, some of us had cold showers while others chose to wait in the hopes that the power would be returned shortly. (Continued page 19)

Monday morning came and there was still no power or hot water. Many of the attendees who had weathered the storm were starting to feel weathered themselves. Social determinants of health were literally at play and morale was showing signs of waning. In comparison to the path of destruction that Hurricane Dorian left in its tracks leading up to Halifax, these were essentially only inconveniences, providing a good perspective on the importance of emergency preparedness and management measures in the wake of disasters.

The conference planning committee started their contingency plan: we continue on, without microphones, no PowerPoints, decreased number of presentations, not to mention a room of over 200 delegates sitting mostly in the dark. As the announcements were proceeding, and with a schedule delay, the emergency lights cut out for a split second. Then the ventilation system slowly turned on, followed by one set of lights, then another, and slowly the room started to light up from left to right as everyone clapped and shouted in relief. I started taking a video once the first set of lights came on and would like to share it with the rest of you. It was a moment that brought everyone together to celebrate, feel thankful for the amenities that were restored, that we had weathered the hurricane, and that CIPHI could proceed with the conference despite the setbacks.
