

New MOH appointed

On May 28th Mayor Jack Volrich announced the appointment of Dr. David R. Kinloch as City Medical Health Officer. Dr. Kinloch is expected to join the Health Department in July of this year. He is replacing Dr. G.H. Bonham who resigned to join the Provincial Government's Ministry of Health in Victoria.

Dr. Kinloch, a Canadian, obtained his M.D. degree from the University of Alberta in 1958 and, following residency and general practice in Victoria, continued his studies at the University of London's School of Hygiene and Tropical Medicine. There his field of special interest was Epidemiology and he obtained his Diploma in Public Health in 1962. Later he attended Harvard University's School of Public Health and in 1972 was certified as a specialist in this field by the American Board of Preventive Medicine.

Formerly Deputy Commissioner in the Massachusetts Department of Public Health, Dr. Kinloch has also occupied senior public health positions in Canada. Between 1973 to 1977 he served in Quebec as Special Advisor to the Deputy Minister of Social Affairs (Health, Policy and Programs) and as Provincial Director of Planning for Health Services. 1973 he was Medical Director of the Ontario Health Insurance Plan. His earlier experience includes government service in the Yukon and North West Territories and in Massachusetts as Director of Medical Care.

The eligibility requirements and criteria are as follow

ELIGIBILITY:

Only relatives of BCGEU members in good standing or relatives of deceased or retired members are eligible to apply, i.e. spouse, parent, child, brother, sister, grandchild.

REQUIREMENTS:

- 1. Must have an academic standing of C+ or better in previous year's courses and in courses presently enrolled in. For mature students this requirement would be waived.
- 2. A personal letter to the Committee explaining why th are applying for this scholarship and detailing their academic goals and career plans.
- A typewritten essay of 1,500 to 2,000 words about the "role of Public Service Unions in your community and how they affect you". Accompanying this essay must be a list of the Unions in their community, all reference material noted, and personal contacts should also be noted.
- 4. An indication of their career plans (back of application form) .
- 5. A summary of estimated expenses (back of application form).
- 6. A list of other scholarships they have applied for (back of application form).
- 7. A transcript of last year's marks as well as an attested record of this year's marks.
