#### **Constitution and By-Laws Update**

We have been busy this spring primarily working on the review and redevelopment of our Constitution and Operational By-laws. This was as a result of the New BC Societies Act which came into effect this year. As we were obliged to update, we took the opportunity to clean up some of the antiquated clauses and wording and have a final draft that is being reviewed for final comment amongst the current Executive Council. Once this process is complete, we will then circulate to the BC Branch Membership at-large for input on the content as well as the preference for the type of society we wish to be. While the purpose of the BC Branch is to extend the work of CIPHI National, the key question that is before us is with whether we would like to become a member-funded society or not. We will be exploring the pros and cons of maintaining the status quo or changing to a member -funded society and we will provide a synopsis with the draft documents to be circulated. Stay tuned for more details on this matter over the next couple months.

This past February, I was given the opportunity to attend the National Executive Council Meeting in Halifax, NS as part of my transition year as President Elect towards being the BC Branch President. I personally found it to be a very rewarding and valuable experience. # "Getting to Know You" - Fraser Health Leadership

### Oonagh Tyson, Regional Director, Health Protection



Oonagh Tyson is the Regional Director of Health Protection at Fraser Health. Her portfolio includes Environmental Health, Community Care Facilities Licensing, Tobacco, and Healthy Environments. She has worked for Fraser Health since 2000, starting as a Public Health Inspector in the Surrey office. In 2006 she became the Environmental Health Manager for the Tri-Cities, Maple Ridge, and New Westminster areas. She was involved in the creation of Fraser Health's Healthy Built Environment team in 2012 and managed this program until assuming the Regional Director portfolio in 2014. Prior to starting with Fraser Health, Oonagh worked as an Environmental Health Officer for Health Canada, First Nations and Inuit Health in Williams Lake, covering 13 First Nations communities. Oonagh is passionate about exploring innovative ways to incorporate Health Protection in health promotion and community work, thereby increasing its role and improving health outcomes among the population.

Oonagh's educational background includes a Master of Science from Royal Roads University and a Bachelor of Science from UBC. She graduated from BCIT's Environmental Health program in 1998. When not at work or spending time with friends and family, Oonagh enjoys taking her dog (Pumpkin) to fun canine activities such as sheep herding, agility, dock diving, and obedience training.

# Gord Stewart, Manager, Burnaby and New West Health Protection

Gordon Stewart is the Health Protection Manager for Burnaby/New Westminster. Gord graduated from BCIT and was Certified in 1982. He began his career in Fort McLeod, Alberta with the Chinook Health Region. Gord left the Chinook HR in 1990 as the Chief PHI to return to the Lower Mainland. While in Fort McLeod Gord became a strong supporter of food safety education programs for operators and employees in the local food industry. Gord was active in the development of the Chief Mountain Solid Waste Authority (CMSWA), in an effort to control open pit garbage dumps. The open pit dumps burned regularly as a waste reduction strategy and method to recover material for recycling. The



CMSWA was organized to secure funding to create transfer stations for each participating town and First Nations community and secure a site for a sanitary landfill.

In 1990 Gord joined the staff at Boundary Health Unit in White Rock and continued teaching food safety courses to food premises operators and staff through the local continuing education program. As Boundary HU expanded he became a Deputy Chief and began managing the Food Control Program. In his current role Gord is the program lead for the Emergency Preparedness program, Regional Billing program, and Health Protection Manager for the Burnaby and New Westminster communities.

Gord is an active supporter of CIPHI and participated as a Branch Councillor, Examiner, Examination Coordinator, and Chair of the Board of Certification. Gord is also currently a member of the National Exam Panel.

## Timothy Millard, Manager, Abbotsford, Chilliwack, Mission Health Protection

After graduating from Trinity Western University with a BSc and completing the Environmental Health Program at BCIT in 1994, Timothy spent three years working for Boundary Health primarily in the land use program. His love for helping and educating people pulled him in a different direction for more than seven years as he became the Head Instructor / Manager of a large Martial Arts School in Surrey.

In 2004, Timothy returned to Fraser Health, working out of the Surrey Health Protection Office. Due to his love for education, he started teaching FOODSAFE right away and soon became the FOODSAFE Co-ordinator for Fraser Health.

In 2012, Fraser Health started to implement the use of tablets in the field, and he saw this as an opportunity to continue to help and educate others; however, now his focus was on helping EHOs.

In January, 2014, a management position became available and Timothy saw this as a further opportunity to impact the most people by being a resource that EHOs can turn to in a variety of situations. As a manager, he has particularly enjoyed challenging EHOs to explore different options and to think outside the box, especially when a situation is either unclear or difficult.



Timothy has enjoyed his first three years as manager, and has been fortunate to be part of a great TEAM supporting the Fraser East communities with EHOs and Admin Support in three offices: Abbotsford, Chilliwack, and Mission. He also sits on the Provincial Committees for Recreational Water and Personal Service Establishments.

# Ken Shaw, Manager, Delta/White Rock and Langley Health Protection



Ken attended BCIT and obtained his CPHI(C) in 1991. Prior to this, he worked as a Marine Engineer for a number of shipping companies. His first job as a health inspector was in Timmins, Ontario where he covered a district that stretched up into James Bay.

Ken came to BC in 1992 and started working for the old Simon Fraser Health Unit in a small office alongside Keir Cordner, where together they tackled the challenges of administering the Sewage Disposal Regulation.

Ken continued in the role of an informal specialist in sewage disposal up until the time the sewage legislation was changed in 2004. After this, he was successful in obtaining an EHS Manager position.

Since that time, Ken has worked in geographic programs, as well as regional programs including tobacco control, healthy built environments, and human health risk assessment. He

is also engaged with collaborative work in health equity and injury prevention.

# Sandra Gill, Manager, Environmental Health Services & Healthy Built Environment Program

Sandra is the Manager of Environmental Health Services for Tri Cities and Maple Ridge areas, and the regional Healthy Built Environment program for Fraser Health. She also participates in various capacities for initiatives that span across the Population and Public Health portfolio including chronic disease prevention, health equity and diversity, and workforce development.



Sandra's educational background includes undergraduate degrees in Biological Sciences and Environmental Health, and a Master's degree in Public Health from the University of British Columbia. # In Memoriam—Laurel Benham

Laurel Edgar Benham was born July 27, 1918 at Hardisty, Alberta. Upon graduation from high school he took training to become a school teacher. Laurel taught school for 2 years before the start of WWII. He joined the Royal Canadian Air Force and took training to become a Wireless Radio Instructor. He won the Gold Medal for Canada due to his expertise and skill in this subject. He then taught Wireless Radio Operation to air force gunners at No. 2 Wireless School in Calgary, Alberta. In 1943 he met Hugh Bownes a Sanitary Inspector in Red Deer, Alberta who told Laurel about the course offered by the Canadian Public Health Association to become a Sanitary Inspector. Hugh strongly encouraged him to take the course due the potential for a great career. On his own time he took the required courses and then obtained the needed practical experience at the Calgary Health Department. Laurel was awarded his Certificate in Sanitary Inspection (Canada) #301 in 1944.

When the War was over, Laurel applied for a position in the Central Vancouver Island Health Unit and was stationed at Port Alberni. There he encouraged local restaurant operators to form an association and work together on food safety issues. The association was formed and Laurel presented food safety courses to

operators and their staff. Laurel received much praise from the local restaurant owners for his leadership in this situation.

In 1948, Laurel transferred to the newly created Cariboo Health Unit and was stationed in Prince George. His office was in a WWII "Army Hut". Laurel and his wife Mavis and son lived in a small house provide by the Dept. of Health. That winter the temperatures dropped to -65F and he had to hang blankets over all the windows and doors to keep out the cold. At 3:00 a.m. each night he had to refill the small Quebec Heater to keep the house warm. Initially he was the only Inspector in the health unit but within a year, Len Hiebert was hired and stationed at Quesnel and thus Laurel was promoted to Senior Public Health Inspector. Again he encouraged local restaurant operators to form an association and work together on food safety issues and again Laurel presented food safety courses to operators and their staff. In May 1950 the family was blessed with a daughter. After two years living and working in these very challenging conditions Laurel and family transferred to the Vernon office of the North Okanagan Health Unit where they stayed until 1961.

Laurel was drawn to the Vancouver Island area after several visits to Victoria and when a vacancy became available Laurel transferred to become the new "Chief" of the Provincial Saanich and South Vancouver Island Health Unit. Later

that same year this health unit as well as the Victoria & Esquimalt Health Dept. were amalgamated into the Greater Victoria Metropolitan Board of Health. Laurel was promoted to the position of Assistant Director a position he held for two years until the Director retired and he was promoted to the position of Director.

In 1966 Premier WAC Bennett created Regional Districts across BC and the Capital Regional District was the first regional district created. In 1974 all Community Health Services were added to the responsibilities of the CRD and Laurel was appointed the new Director, Division of Public Health Inspection, a position he held until his retirement on December 31, 1977.

Laurel was never one to sidestep challenges when faced with them. In the Okanagan he tackled a large Milk Cooperative over poor quality control. He took on City Council for allowing poorly treated effluent from the treatment plant to pollute a stream and public beach. Both situations became highly political but Laurel was proven to be correct and he successfully "weathered the storm".

In addition to his work as a PHI Laurel was highly involved in his profession and for many years as a member of the Provincial Inspectors Salary Negotiating Committee. He was a long standing member of the BC Branch Executive and from 1968 to 1970 was CIPHI National President with a further two years a Past National President. Fortunately Laurel wrote many stories during his career including an excellent report on the 1948 disastrous and deadly flood in the Fraser Valley and his humorous story of a field trip in the north titled "Carefree Days in the Cariboo Health Unit" plus other historical recollections.

Laurel was an eloquent spokesman for the profession and regularly used the press including radio and TV to promote environmental health protection. As National President he met BC Premier WAC Bennett and other politicians. Laurel was the longest certified Public Health Inspector in BC history at 72 years and 2<sup>nd</sup> longest in Canada to date. Laurel passed away in November 2016 at the golden age of 98. He will certainly be missed as a good friend to many and a true leader of our profession.

## In Memoriam—William Carl Hutton



William Carl Hutton was born in Chicago, Illinois on January 1<sup>st</sup>, 1930. The family moved to Toronto when Carl was 6 months old. He graduated from Meistershaft Secondary School with a swimming scholarship to the University of Indiana. He returned to Toronto to attend the first classroom PHI program in Canada held in conjunction with Ryerson and graduated with top honours as a Public Health Inspector. He was awarded his CSI(C) #878 in 1953. Carl moved to Vancouver to work for the City of Vancouver as a Public Health Inspector in 1954. He advanced in his chosen profession to become

Director of Environmental Health and retired in 1990 after 36 years of service. During his career, Carl became quite involved in the BC Branch of CIPHI and was a member of the Executive for much of the 1970s. When not directly involved in the Institute, he continued as a



strong supporter of the association and encouraged staff attendance at educational conferences sponsored by CIPHI. He was highly regarded by his staff, as well as other City, Municipal, and Ministry of Health officials.

Carl passed away peacefully with his family by his side on January 31, 2017. He is survived by his wife Margaret; daughters Jane, Donna, Steven, Kym; sister Joan Vanston plus six grandchildren. A wonderful Celebration of Life service was held on March 9<sup>th</sup> at the Sunrise Banquet and Conference Centre in Surrey.
