

Retirees Appeal Supreme Court Decision

The class-action lawsuit over health care benefits denied to retired government employees continues. In the last instalment in the Fall Issue of the *BC PAGE* I indicated that Madame Justice Dorgan of the BC Supreme Court tossed out the retiree's suit. In her ruling Justice Dorgan stated the government did not have a "fiduciary duty" to fund the benefits, and that doing so would affect the level of benefits of future retirees.

The action was initiated because retiree Fred Bennett, the Plaintiff, alleges that the British Columbia Provincial Government breached its contractual and fiduciary obligations to members of the British Columbia Sector Pension Plan in October, 2002, when it unilaterally announced that it would no longer pay 100% of the cost of premiums for Medical Services Plan Benefits and Extended Healthcare Benefits of the retirees. The action seeks damages for breach of fiduciary duty and breach of contract. This case has already been to the Supreme Court of Canada where the right of the Plaintiff to initiate a class-action lawsuit regarding this matter was upheld by that Court.

The decision by Madame Justice Dorgan has now been carefully reviewed by Legal Counsel for the BC Government Retirees Association and with the overwhelming support of the association members at the Annual General Meeting and Table Offices, a decision was confirmed to proceed with an appeal. Retired Supreme Court Judge, Thomas Berger, will handle the appeal on a contingency basis.

Thomas Berger, O.C., Q.C., Q.B.C., has been prominent in defending minority rights and establishing the rights of Canada's Aboriginal peoples. He served as a Justice of the Supreme Court of British Columbia from 1971 to1983. During that time, he was Chairman of the Royal Commission on Family and Children's Law, B.C, 1973-74, Commissioner of the Mackenzie Valley Pipeline Inquiry 1974-77, and of the Inquiry on Indian and Health Consultation 1979-80 for the Government of Canada. He is the author of *Northern Frontier, Northern Homeland* (1977); *Village Journey: a Long and Terrible Shadow* (1985); *Fragile Freedoms: Human Rights and Dissent in Canada* (1981), and *One Man's Justice: A Life in the Law* (2002). He acted as Conciliator in 2005-2006 with respect to a series of disputes between the Government of Canada and the Government of Nunavut; his report is called "The Nunavut Project".

West Nile Virus Update

As was expected every summer since 2003, West Nile virus finally showed up in BC in August of 2009. In total, 2 human cases, 3 horses and 10 mosquito pools tested positive with almost all of the reported activity in the South Okanagan region. The lone exception was a horse reported in the Fraser South region of the Lower Mainland at the end of August, although exposure was likely much earlier. Risk modeling performed by the BCCDC correctly predicted the South Okanagan as a high risk area for WNv with its hot summer temperatures, abundant vector mosquito populations and connectedness to eco-regions in Washington State where disease activity was plentiful in 2009.

The single positive horse in the Fraser Valley was not as well predicted, especially as the first reported point of activity in the Lower Mainland. Despite a nearby crow roost and several mosquito traps within 10KMs of the horse property, no other activity was noted.

This serves up interesting possibilities for 2010. Ecological surveillance will certainly be enhanced in both regions where positive activity was noted in 2009. Having the benefit of large crow populations in the Greater Vancouver and Fraser Valley portions of the Lower Mainland, early detection of avian disease activity should be possible provided dead corvids are reported and collected for testing. Public messaging about the corvid surveillance program will have to improve, especially in July and August when disease activity peaks.

The Okanagan will not rely as much on corvid surveillance as a measuring stick for disease activity in its areas, due to lower corvid densities. However, use of the BCCDC's online dead bird reporting will continue to be encouraged for the Interior. Mosquito surveillance was increased with the first positive in 2009. This extra mosquito surveillance will continue in 2010. There will also be increased emphasis on public education at the start of the season and, again, part way through season.

Fraser will again have a compliment of over 60 mosquito traps in use, although they may be less spread out in favour of a selection of trap groupings to improve catch volumes. Trapping will occur weekly from June through September.

Monitoring BC residents will again be done through Canadian Blood Services screening processes and reporting by clinical diagnosis through doctor's offices and Emergency rooms.

Many local governments and First Nations will also take part in the UBCM West Nile Risk Reduction Program. This program provides funding for eligible WNV control programs in areas at risk. A variety of control measures are employed in these programs to control mosquitoes and participate in public education initiatives.



Blood Clots/Stroke - They Now Have a Fourth Indicator, the Tongue



STROKE: Remember the 1st Three LettersS.T.R.

Doctors say a bystander can recognize a stroke by asking three simple questions:

- S * Ask the individual to SMILE.
- T * Ask the person to TALK and SPEAK A SIMPLE SENTENCE (Coherently) (i.e. It is sunny out today.)
- R * Ask him or her to RAISE BOTH ARMS.

If he or she has trouble with ANY ONE of these tasks, call emergency number <u>immediately</u> and describe the symptoms to the dispatcher.

New Sign of a Stroke ----- Stick out Your Tongue

Ask the person to 'stick' out his tongue. If the tongue is 'crooked', if it goes to one side or the other, that is also an indication of a stroke.







In Memoriam



Stephen Chamut October 3, 1915 – December 24, 2009

Stephen passed away peacefully on December 24, 2009 in the Nanaimo Regional Hospital with members of his family at his side. He was predeceased by his loving wife Doris; who passed away on December 1, 2003, after 61 years of marriage. He is mourned by his son's Robert, Patrick, and Brian, his daughters in law Vivian, Linda and Shirley, his grandchildren Stephanie, Kristin, Colin, Stephen and Kimberley and his great grandchildren Estelle, Connor and Selina.

Stephen was born on October 3, 1915 in Port Arthur Ontario and was the eldest of five children. Displaying the independence that characterized his life, he left home at the age of 16 to work in the lumber industry of Northern Ontario. In 1940 he enlisted in the Royal Canadian Air Force, and trained to serve as a wireless air gunner eventually reaching the rank of Flight Lieutenant. During training, he met Doris Hider, a young nurse at the Calgary General Hospital, an event to that he regarded as the most fortunate occurrence in his life. They married on February 28, 1941. After completion of training, he volunteered to serve in Ferry Command, and spent the early years of the war based in Montréal flying aircraft across the Atlantic to resupply the British RAF. The many twists of fate that kept him safe from fatal accidents that claimed the lives of his colleagues convinced him that he had a personal guardian angel looking after him. He was transferred to the West Coast following the declaration of war with Japan, and spent time patrolling the coast of B.C. and Alaska. He volunteered to return to Bomber Command in Europe and arrived there just as the war in Europe ended.

Following the war, Stephen settled on Vancouver Island. He joined the provincial Public Service in 1958 and obtained his Certificate In Sanitary Inspection (Canada) in 1959. He worked as a Public health Inspector in Nelson, Campbell River, and Chilliwack. He retired in 1980 from the position as Chief Public Health Inspector for the Upper Fraser Valley Health Unit. He was an avid golfer and skier and it was a source of pride that he was able to keep up with his grandchildren on the ski slopes at the age of 85. Following the death of his wife, Doris, in 2003, he continued to live independently in Chilliwack until August 2009, when he moved to Origins at Longwood in Nanaimo.

The family's deepest thanks are extended to the staff at Origins for their care and attention, and for enhancing the quality of his final days. Steve had a long life, blessed with good health and good fortune. While he was demanding and at times difficult, he demonstrated through his behaviour the importance of honesty, duty, integrity, self-reliance and hard work in making your way in the world. He will be missed by all his family and friends.
