Student's Corner - First Nations University of Canada

10th Annual Professional Educative and Development Seminar



As a student, I felt honoured to be in midst of Public Health Inspectors throughout Saskatchewan and privileged to participate in the 10th Annual Professional Educative and Development Seminar that took place on September 26, 2017 at the Saskatoon Inn and Conference Centre. The conference was embedded with different topics and activities that were comprehensive, educational and informative for the practice of public health inspection. The topics discussed during the conference included food processing, microblading, and tobacco retailer ticketing. The discussion on water system approval gave detailed information about the guidelines to Establish, Extend, Renovate or Alter a Groundwater public water supply. Long and short applications are to be submitted to local authorities for approval so that minimum criteria are met for acceptable water quality. It is also expected that the designers comply with good engineering practices and to supply evidence supporting the design. The

owners have a responsibility to ensure that the water supplied for drinking water is suitable for human consumption.

This conference introduced me to many new things, including microblading. I was so surprised to hear about microblading for the first time. I learned that it is a form of permanent make up where the pigment is placed superficially on skin of the eyebrow area using a hand-held device. Public Health Inspectors are concerned about possible infections such as HIV and hepatitis when untrained artists practice the techniques in unsafe conditions, as microblading involves breaking of the skin. It was reported that customers may suffer infections after this procedure from poorly trained personnel. The infection may include puffiness, redness, itching and pus in the affected area. Another concern is the microblading pen, it was reported that some artists may be re-using the pen. Therefore, the public is advised to patronize licensed shops that use a single-use microblading pen.

I was so excited to attend the conference to learn about these public health issues and meet with my colleagues in the field. Thank you for the opportunity to participate!

I was born and raised in Prince Albert, Saskatchewan, and moved to Saskatoon in 2004 to launch my post-secondary education. My name is Andreas Giannios, I have been a certified Public Health Inspector since June 5, 2010. I grew up in Leukada, Greece and my parents were sheep/goat farmers, and my interest in public health started at a very early age. We used to make feta cheese, butter, yogurt, and other products from the milk. I vividly remember auditing my grandpa's processing steps while he was making these products and always tried to catch his "short cut" while he conducted his milk pasteurization steps. In 1998, our family moved to Preeceville, SK as my dad decided to get into the restaurant industry.

The restaurant industry has a direct link to Public Health Inspectors, and that's where my family got to experience such a wonderful, positive, educational relationship with the Public Health Inspectors of the Sunrise Health Region. During our 15 years of owning a business in Preeceville, my father would turn to our health inspector, Mr. Gilbert Combres, for direction and process as he was expanding / renovating the restaurant.

I attended the University of Saskatchewan for two years, but really never got interested in acquiring a degree. I took three years off from post-secondary education and during that time I fulfilled my mandatory 1 year of service requirement with the Greek Military. Following the Military I worked in Greece for 2 years on a cruise ship and spent quality time with my grandparents. When I returned to Canada the restaurant life was not for me, so I proceeded to search for a profession and that's where Mr. Gilbert Combres inspired me to become a health inspector.

I obtained my 4 year Environmental Health and Science degree from the First Nations University of Canada in Regina, SK, and started my practicum with the Saskatoon Health Region. I worked for a short period of time in the Humboldt district office and now currently work as a full time employee in the Saskatoon office. This profession is so great! You get to work with people, make a difference in your community, enjoy different experiences every day, and have an opportunity to grow, inspire, and be inspired by those around you.

A Day in the Life ... Pelican Narrows Evacuation 2017

Residents from Pelican Narrows were first evacuated to the Henk Ruys Soccer Centre in Saskatoon on August 29th, 2017. Residents were able to go back home Sept 19th, 2017.

473 evacuees were sent to the center to start with, while those individuals that were ill and their families were sent to two local hotels.

On August 31st 2017 numbers went up to 531 at the Soccer Center, and 204 people between the two local hotels. The numbers fluctuated as evacuees moved around during this time.



What was the Role of the Public Health Inspector?

Public Health Inspector involvement on Aug 29th at the center included working with the Salvation Army who was involved with receiving the meals from Prairieland Park by courier, and distributing the food to the evacuees three times a day.

It was important to have a method of hand washing for the evacuees so portable hand wash stations were delivered to the dining area. Public Health provided signage to remind evacuees to wash and or sanitize their hands before eating.

Working with facility maintenance ensuring that the washrooms were labeled properly as multiple team change rooms were used for this purpose. Garbage cans were provided, areas that didn't need to be accessed by the evacuees were secured, etc.

Inspectors partnered with Emergency Social Service and provided the evacuees with condoms.

Inspectors partnered with Red Cross in letting the evacuees know where the bottle changing and toy cleaning room was. It was kept locked and the key had to be provided by the Red Cross to gain entry.

Pelican Narrows Evacuation Continued...

Public Health also put up posters to help evacuees to know where to go if they were ill, or needed to dispose of needles. The SktnHR Public Health Bus was redeployed to the Soccer Center for the first week in order to help the evacuees with health issues they were encountering.

Daily contact by the Health Inspector to the Evacuation Manager on Call for Public Health via text to say what was seen and what was changed or enhanced (this was to keep Public Health Management in the loop). Larger issues identified by Inspectors were forwarded to Management who would take part in a daily multi discipline agency meeting to discuss.

Public Health was to ensure that change rooms and showers were identified and labeled properly, hand washing posters and hand sanitizing stations were set up during meal times

A clinic inside the soccer center was set up at the end of the first week.

For the first week, Inspectors were on site for every meal delivered until the system proved to be working, at that time a spot check was implemented once a day during a meal.

During this spot check the following was looked at:

- ⇒ Check of the kitchen area for temperatures, storage conditions, and sanitation level including insect and rodent control.
- ⇒ Check on baby bottle room and replace water and clean if needed.
- ⇒ Have a representative from the Red Cross accompany the Inspector around the sleeping areas to identify whether or not hazards exist (cots stacked up on top of one another to form barriers, etc.). One of the issues that was identified was that food had been snuck in from the dining area and stored under the cots.
- ⇒ Look for signs of illness and ensure that garbage is being taken out especially in the morning when maintenance was finally allowed in (including picking up diapers that were changed in the sleeping area instead of in the washrooms during the night). The temperature was monitored as much as possible as it was 30C during this time.
- ⇒ If issues were identified, the Inspector would go to the responsible agency to notify them of the need to do something. Each site visit resulted in a hand written inspection report, placed into a binder and kept at the office.
- ⇒ Cots were looked at during the walk around and if messy they were taken out of use and replaced. Cots were pressure washed with steam after two weeks to keep germs from spreading.
- ⇒ Check in on the cleanliness of the washrooms and showers.

No inspection was done at the local hotel until later in the event when a concern was brought to our attention that food was being improperly handled by the Red Cross, at which time an inspector went over to talk to both the kitchen staff and the Red Cross who set up a mini market in the dining area of the hotel.

On Sept 9th, 2017 the community wanted to put on a traditional BBQ for evacuees which included moose meat. Public Health Inspectors had to work closely with the Salvation Army and the community to ensure that the function met with Technical Guideline 169.

Toy cleaning was identified as an issue due to the number of children at the Soccer Centre. The Red Cross was tasked to do some toy cleaning on a daily basis, and signage was provided to follow for cleaning of the toys.

For outbreak management, Public Health Inspectors asked and/or listened daily to find out if there were any illnesses overnight and worked closely with the Communicable Disease department.

Daily inspection checks done by the Inspectors were done during a meal time and were documented up until the end of the evacuation.

On Sept. 19th, 2017, the end of the evacuation, Public Health went to pick up posters and clean up the baby bottle room. Henk Ruys Soccer Centre facility maintenance staff requested that Public Health return in a few days to clear the facility after they did some enhanced cleaning and disinfection of the soccer pitches, floors, walls, doors and other common contact surfaces in the washrooms, shower facilities and the dining area.

The Honorouble James A. Calder

September 17, 1868 - July 20, 1956

A Canadian politician, born in Oxford County, Ontario. He received his Bachelor of Arts degree from the University of Manitoba in 1888. He was a teacher and principal, before being elected to the Legislative Assembly of Saskatchewan for the riding of South Regina in the 1905 provincial election.

A Liberal, he was re-elected in a 1908 by-election and in the 1912 election. From 1905 to 1912, he was the Minister of Education, Provincial Treasurer, and Minister of Railways.

The rural village of Calder, SK was named after him when it was incorporated in 1911. From 1916 to 1917, he was the President of the Executive Council, Minister of Railways, and Minister of Highways.

He was elected as an Unionist candidate to the Canadian House of Commons for the riding of Moose Jaw in the 1917 federal election. He held many ministerial positions including Minister of Immigration and Colonization, Minister of Agriculture (Acting), Minister of Militia and Defence (Acting), President of the Privy Council, and Minister presiding over the Department of Health.

In 1921, he was called to the Canadian Senate, appointed on the advice of The Rt. Hon. Arthur Meighen, representing the senatorial division of Moose Jaw, Saskatchewan. A Conservative (and later Progressive Conservative), he died in office in 1956.

Calder was a noted philatelist who signed the Roll of Distinguished Philatelists in 1947.

CONGRATULATIONS JOHN!

John Bartram has retired from the Saskatoon Health Region after 35 years.

John first became interested in public health inspection because his older sister and brother in law were PHI's in Ontario. He liked the variety in the work and the ability to be out and about not in an office all day. John attended Ryerson. He graduated in the last two year certificate class.

John first worked in Thunder Bay for the Northern Ontario Public Health Service driving many miles inspecting facilities in unorganized territory. More remote locations required travel by float plane and boat. It was challenging for a new inspector because eventually John was the only PHI in the district.

In 1982 John joined the Saskatoon Community Health Unit working with four other inspectors and one chief inspector. At that time public health inspectors worked for the City of Saskatoon and John was the young inspector mentored by a team of veteran inspectors.

What inspectors do has changed over the years. John recalls doing inspections of funeral homes, contact tracing in sexually transmitted disease cases and innumerable indoor air quality tests for formaldehyde in homes. He also recalls enjoying a one week Emergency Preparedness course he attended at a military base in Ontario. A particularly memorable event in John's career was a visit by Queen Elizabeth to Saskatoon. The food preparation facility required a meticulous inspection and two identical meals were prepared: one was for the Queen to eat and the other was kept for potential analysis in case the Queen suffered a food borne illness.

How inspections are documented has changed significantly in 35 years. John has gone from paper forms and carbon paper to doing inspections electronically in the field.

John has always appreciated the variety his career offered him. He particularly enjoyed insect identification, pool inspections, solving indoor air quality problems, mentoring student PHI's and teaching Food Safe classes to special needs students. His last two years working as a Senior PHI and the Program Expert for the pool program and injury prevention was interesting and a nice change of pace.

John will miss the relationships he built with operators and others in the community. The thing he will miss most is the camaraderie of his coworkers.

In retirement John looks forward to relaxing, travelling and no alarm clocks!

Canadian Institute of Public Health Inspectors

Honorable Dr Eric Hoskins.

The Saskatchewan Branch of the Canadian Institute of Public Health Inspectors **strongly opposes** the proposed amendments to regulations made under the Health Protection and Promotion Act. Our specific concern relates to the proposal to remove existing public health professional qualification requirements for public health inspectors, that being the Certificate in Public Health Inspection (Canada) (CPHI (C)), from Ontario Regulation 566 Qualifications of Boards of Health Staff (s.5).

Certified Public Health Inspectors in Canada devote their careers to essential public health services across Ontario and Canada. Certified Public Health Inspectors have invested years of post-secondary education, practicum and on-job training and have passed written and oral exams to obtain their Certificate in Public Health Inspection (Canada). All of this is done to ensure they have the specialized skills and knowledge to protect the health of the public through their work. Certificate holders are required to maintain ongoing education requirements and adhere to a strict code of conduct.

By removing the professional qualification, the public will no longer be assured that highly trained professionals will be protecting the health of the public through inspections, consultations, training and enforcement activities.

On behalf of our Branch Membership, I respectfully request you oppose this proposed amendment and ensure the health of the public is protected by Certified Public Health Inspectors, by retaining the CPHI (C) qualification within the regulation.


