



Sask. Ministry of Health update

The following provides information on some of the activities that staff from the Ministry of Health- Environmental Health Unit are currently involved with:

National Level

- Health Canada's Task Group for Guidelines on Wind Turbine Noise for Canada. A draft of the guideline should be ready by summer of 2011.
- Health Canada's Steering Committee for a National Bed bug Strategy. Currently focusing on a national integrated pest management approach and public awareness publications.
- F/P/T Food Safety Committee. Current work involves pathogen reduction in specified foods and surveillance.
- CSA standard work on onsite wastewater and cisterns.

Provincial Level

Regulations/ Standards/ Best Management Practices

- The Plumbing Regulations are nearing completion. These regulations will adopt the 2005 National Plumbing Code and will allow for water reuse and require water efficient fixtures.
- The Private Sewage Works Regulations, which contain the sewage related sections in the current Plumbing and Drainage Regulations, will be completed at the same time as The Plumbing Regulations.
- Work continues on amendments to The Swimming Pool Regulations to address lifeguard gualifications.
- The Public Eating Establishment Standards have been finalized and distributed to the regions. It is also available on the Ministry of Health website.
- The Food Processing Facility Best Management Practices document is expected to be completed shortly. The document will be printed and distributed to the health regions. It will also be available on the Saskatchewan Ministry of Health website.
- The new Swimming Pool Standards and Whirlpool Standards are nearing completion. The Ministry of Health is working with the Ministry of Labour Relations and Workplace Safety (OH&S) to resolve issues regarding chlorine gas rooms

Other Activities

- 'Canada's Foodborne Illness Outbreak Response Protocol (FIORP), 2010' was updated in the summer 2010. The protocol is designed to: guide collaboration in the identification and response to outbreaks affecting more than one province/territory; describe general principles; define roles and responsibilities (health region, provincial and federal partners); and focus on information exchange and communication. A FIORP training exercise was held in Regina in January, 2011 and was well attended by officials from health regions and other agencies.
- Work continues on moving towards implementing the new subdivision review process for subdivisions proposing to utilize onsite wastewater systems. Stakeholder consultations have finished and the Ministry is working with steering committee members to resolve the comments. The Ministry has also published new policies with respect to offering comments on subdivision proposals.

Ministry of Health Update Continued

- The Ministry is working with the Western Canada Onsite Wastewater Management Association to ensure that there is a sewage installers' course offered in Saskatchewan that is based on Saskatchewan requirements.
- Additional fact sheets regarding onsite wastewater can be found on the Ministry of Health website.
- The Ministry will be partnering with Alberta Health and Wellness in conducting a biomonitoring study. The study will involve the environmental contaminant analysis of blood from Alberta and northern Saskatchewan pregnant women.
- The Ministry of Health's "Health Status Report" will include a section on Environmental Health. Data from EHS and CNPHI –water advisory module will be included in this section.
- The Ministry is currently developing a business case for establishing a new (provincial) environmental health data management system that will address both the needs of the health regions and the Ministry.
- The Ministry continues to work with other agencies on the plans to transfer the plumbing from Health to another agency.
- The Ministry is participating on various committees involved with the Ministry of Environment's Environmental Code. When completed this code will replace various regulations that are administered by Environment.
- Work has commenced on establishing the Saskatchewan Population Health Council- Safe Environments
 Theme Group. Priorities for this theme include: human health risk assessment; food safety; water safety and housing.
- The Ministry is working with Occupational Health and Safety and the Ministry of Education in developing a
 risk assessment tool that will be used be used by school officials in addressing deteriorating HVAC systems
 in schools.
