I was able to accompany Ryan Philipation as he made valuable contacts with the sponsors and exhibitors at the conference. Together we were able to highlight our upcoming Professional Education and Development Seminar (PEDS) in November. Ryan was successful in signing up sponsors/exhibitors on the spot; some are returns while others are new exhibitors interested in attending our Branch Conference. Ryan did an outstanding selling job on our seminar and most of the time slots were filled while in Kananaskis. Good job Ryan! This should prove to be another exciting and must attend SK Branch PEDS.

SK Branch did themselves proud with more than a dozen delegates in attendance. The SK Branch presence was well noticed at all the educational and social events. Not only did we show our professional side but our physical fitness as well.

Nova Scotia/PEI Branch will host the 2011 AEC in Halifax. Tentative dates are June 26-29th. The NS/PEI Branch submitted a very impressive proposal and look forward to an exciting and entertaining conference.

The Awards Luncheon was held with many receiving honors, especially our own Ryan Philipation being successful in receiving the Alex Cross Award. The award is issued to a Member for displaying the highest standards of professional practice during the past year. Ryan received the award for his outstanding work on our SK Branch Conferences. Ryan was surprised to receive this award as he was also nominated for the EHFC's NSF Award for his work on the home study course development and delivery. We were able to keep the Alex Cross nomination a secret right up to when his name was called to receive the award. Ryan was nominated for both awards by Doug Terry and me. Congratulations Ryan for your achievements and hard work towards the betterment of Membership and the SK Branch.

AGM: all motions were passed except the motion to decrease retirees and student fees was withdrawn by the mover of the motion. The creation of the Council of Professional Experience (CoPE) was approved as was the redefining of the Regular Membership to include participation in policies and procedures developed by CoPE. CoPE will oversee and administer the professional development model that CIPHI is proposing as work continues to meet the January 1, 2010 deadline. The Council will work to finalize the necessary framework in order to ensure a smooth roll out of the program.

The motion to increase Membership fees in 2010 was passed. Subsequently the CIPHI Membership fee will now be \$175.00, an increase of \$20.00 for 2010 Members. This meager increase is necessary to support the

various projects and initiatives being undertaken, including the continuing professional competencies model that CIPHI is currently developing. Compared to other professional organizations our Membership fees are considerably lower however the bonuses of CIPHI Membership are overwhelmingly superior to others.

A first and milestone for CIPHI was the appointment and acceptance of the President-Elect position for CIPHI National. Phi Phan the now Past President of the Alberta Branch, is the first President-Elect for CIPHI. Congratulations Phi and we welcome Koreen Anderson as Alberta Branch's new President.

At the Pre – President Banquet get together in the President's room I was surprised with the CIPHI Certificate of Appreciation for my lasting contributions to CIPHI as the NEC Representative to the BOC. A position I was happy to fulfill for two terms. Following that announcement I was also thanked by the Environmental Health Foundation of Canada for my two terms as a Trustee of the Foundation. Again another position I was happy to participate in. I thank CIPHI and EHFC for the recognition.

Mr. Stuart Petrie from England who is doing public health work in South Africa approached CIPHI with the idea of a two week PHI exchange. A ToR is being put together on the possibility of this exchange, more info to follow.

All in all the conference was an excellent opportunity to learn and network with professionals from around the world. I encourage everyone to attend a National Conference at least once in your career. SK Branch is making it possible to attend by offering bursaries to Members in good standing.



ROBERT ERIC BARTLETT

Eric, born February 1, 1921, passed away at St. Charles Manor in Victoria, BC on Tuesday, March 17. Eric was predeceased by his first wife, Shirley (nee Butcher) in 1980; second wife, Helen (nee Oxman) in 2003; and sisters, Marj Eltom (Hilt) of Watrous and Phyllis Wells (Elgin) of Lloydminster. He will be lovingly remembered by his sons, Kirk (Beth) of Victoria and Rod (Jacquie) of Seoul, South Korea; and his grandchildren, Elisabeth, Carolyn, Benjamin and Abigail, Eric grew up on a homestead northeast of Rosetown, SK. He then moved to the Yukon to assist in the WWII effort. After the war, he ran the Travellers Hotel in Hawarden, SK, where he met Shirley. They raised their family in Prince Albert, SK, where Eric worked as a public health inspector. As Eric was promoted, they moved to Regina, Yorkton, and then Saskatoon. It was in Saskatoon in 1980 that Shirley died. Eric remained in Saskatoon thereafter. He spent his retirement years with Helen. After Helen died in 2003, he moved to Victoria, BC to be closer to his family. He will be remembered for his love of walking, his delight in sharing ice cream with his grandchildren, and above all his kind and gentle ways and quiet sense of humour. A private gathering of family and close friends will be held at a later date to celebrate his life.

CIPHI ANNUAL EDUCATION CONFERENCE May 2009 Kanananaskis

I was fortunate to have been able to attend the AEC this year in Kananaskis. I commend the Alberta branch for hosting such an event, both for the location as well as for the content and entertainment. It was very well attended.

My interest was peaked by the motivational keynote speaker Warren MacDonald who essentially sent the message that nothing is impossible if you are focused and determined. Warren's real life experiences make our own seem pale compared to his. Warren's storey resulted in all of us asking ourselves do we really have a valid excuse for not doing something or getting things done as in his case he did not allow mental or physical barriers to impede his determination and goals. He was truly inspirational. 
Overall the renewed friendships and acquaintances, and the new contacts made coupled with the social opportunities provided for a very enjoyable and memorable time.

I recommend that all members strive to attend at least one national AEC in their career.



Dr. John Blatherwick Receives Honourary Degree

Dr. John Blatherwick (Honourary Chair of the EHFC) has been awarded the degree of Doctor of Laws by the University of British Columbia. Below is a copy of his nomination plus a great photo of John with the President and Chancel- He is a father of four and an active participant in communilor of UBC. Please join me in congratulating John on re-ty sports. ceiving this significant award for his years of contribution and service in the field of Public Health. John has been a Madam Chancellor, to recognize his outstanding leaderlong time supporter of PHIs and the field of Environmental Health. He is also an Honourary Member of CIPHI.

Madam Chancellor.

It is a privilege and honour today to recognize the outstanding contributions Dr. Francis John Blatherwick has made to improving the health of Canadians and to serving his country.

Dr. Blatherwick is Canada's longest-serving medical health officer. He has served as a B.C. medical health officer for 36 years and as the Chief Medical Health Officer in Vancouver for 23 years.

As one of British Columbia's best-known public health advocates, Dr. Blatherwick has been a catalyst, innovator, and the driving force behind a number of important public health initiatives.

These include: leading Vancouver's public health response to the SARS epidemic; advocating for harm reduction programs for injection drug users which resulted in the opening of the first supervised injection site in North America; and campaigning against exposure to tobacco smoke which led to the establishment of municipal smoking bylaws and reducing population exposure to second-hand smoke - to name just a few.

He is also the recipient of an impressive set of awards including the Order of Canada and the Order of British Columbia for his work in public health, the George Elliot Award for lifetime contribution to public health in British Columbia and the Silver Medal of Service from the BC Medical Association.

Dr. Blatherwick has served for 39 years in the Canadian Forces Reserves. He represented Canada at NATO as the head of the Canadian Forces Reserve Medical Group for six years. He is the Honorary Colonel of 12 Vancouver Field Ambulance. He has written 20 books, mainly about Canadian orders, decorations and medals, and airplanes.

Health and Science Camp

The First Nations University of Canada, Science Department celebrated its 11th Annual summer Health and Science Camp on July 13th – 18th, 2008. The camp hosted approximately 30 Aboriginal youth who have a long-term goal of improving the quality of life in their communities by choosing to become a health professional. Activities included educational, cultural, and physical activity components. Campers had the opportunity to participate in activities such as a daytrip to the fish hatchery in Fort Qu'Appelle, tour the Provincial Lab, Medicine Walk with elders, tour at Four Directions Health Clinic and IMAX theatre.

Continuing Professional Competencies (CPC) Project Update

I recently attended the CPC Meeting in Toronto November 20 & 21, where work continued at finalizing the project. 30 attendees representing all provinces assisted the Working Group and Health Canada to make the project a reality. As you know we were mandated to develop Core Competencies for Public Health Inspectors with financial assistance from Health Canada. Other professional disciplines (dentists, epidemiologists, etc) have been tasked as well. CIPHI is leading the way with this project's development.

It was a learning experience for all. The meeting was facilitated by representatives from Meyers Norris Penny to the NEC, Stakeholders, the Senators Group, the CPC Steering Committee and the CPC Working Group. From the work completed in the two fully packed days, the "Proposed Design of the CPC Reporting Model & CIPHI Board of Practice" and Discipline Specific Competency Statements" documents were revised and will now go back to the Working Group for redevelopment and clarification.

The CPC Model will be tested on focus groups decided upon at the meetings conclusion. Three levels of professional development will be selected and they will test the CPC's against the work they are presently doing. The three levels are: Front Line Practitioners (holders of CPHI(C)), Consultant/Specialists and Manager/Supervisors. Each level will be tested against the Competency model to assist in the final model.

Progression is continuing as the projected release is slated for the AGM in May 2009.

I would like to thank the SK CIPHI Executive and SK CIPHI Members for the SK. Branch AEC Bursary. I would like to especially thank the Saskatchewan PHIs for your continuing support through your membership of our Branch making this bursary possible. This bursary allowed me the opportunity to attend the Annual Education Conference in St. John's Newfoundland. This was the first out of Province Conference that I have attended.

This year the conference theme was titled "Beyond the Horizon". As in past conferences this year's program featured three concurrent sessions focusing on a number of different topics making it very difficult deciding which to attend. As you may know Newfoundland is a very friendly Province and the people we met went out of their way to make our stay enjoyable. Many of us were made honorary Newfoundlanders which involved being Screeched-In, kissing the cod, and when asked if you are a Newfoundlander repeating "Indeed I is, Ye old cocker, long may your big jib draw" and of course drinking a small amount of screech.


