2016 Annual Educational Conference Student Bursary Report



Attending the 2016 CIPHI conference has provided me with many benefits and rewards; some of which I had anticipated while others that I did not. I departed having gained further insights and knowledge into unfamiliar public health topics and emerging trends in the field. The following is a brief synopsis of the experiences that I have taken away since attending. The topics presented at CIPHI 2016 came from a collection of stakeholders and spanned across

multiple disciplines within the field of environmental health. The topics from industry leaders speaking on the dark side of body modification and tattoo industry secrets provided me with insight into unconventional procedures used to alter the human body and infection control concerns that I have not previously encountered. I was awarded a short glimpse into a world that may not be frequently witnessed by public health inspectors but have been gaining popularity in underground environments.

Attending the conference also provided me with the opportunity to learn about some of the emerging issues faced by public health professionals in Ontario. I was captivated listening to Dr. Catherine Filejski speak on the increase of dog adoption agencies and the public health concern regarding the translocation of zoonotic infections such as rabies and Echinococcus.

Furthering this lesion, Dr. Fiona Hunter's presentation on Zika virus vectors brought forward many interesting questions and concerns regarding the potential for Zika virus transmission to occur in Ontario. The opportunity to engage and learn about emerging issues such as these are one of attractive elements of this field as there are always new challenges around the corner in the field of environmental health.

The topic I enjoyed most was a presentation by Dr. Ray Copes and Paul Di Salvo detailing an investigation into the source of high blood lead levels in a Toronto family. The presentation acted to build my knowledge regarding potential sources of lead exposures and detailed the framework of an investigation used to identify the source. The information presented was both fascinating and inspiring to any inspector just entering

the field and illustrated the impact public health inspectors can have in determining identifying and eliminating health hazards. It can often be difficult to become informed about issues faced by other jurisdictions and the CIPHI conference provided a great forum to discuss and learn from others experiences.

It would be amiss if I didn't mention that attending the conference provided me an opportunity to network with both my fellow coworkers and peers alike. Despite all the benefits I previously mentioned, if only for this reason, I would encourage any student or recent graduate to consider attending the CIPHI conference.



Bjorn has been on the alPHa board for seven years starting in 2009 and has been on the executive committee for the last three years. He will retain that position until his term ends at the end of the year.




