The Longest Certified PHI

A review of the BOC Registry by Tim Roark the CIPHI National Historian has turned up an interesting fact. Lloyd Dodgson has held his CSI(C) or CPHI(C) longer than any other living person in Canada and thus the whole world. The BOC Registry which traces its start to 1934 shows that Lloyd received his certificate in 1938. This means Lloyd has been certified for 78 years. This is quite an achievement and one that the Ontario Branch News is proud to proclaim.

Lloyd Dodgson was born in January 1918 and has dedicated most of his life to health protection in one form or another. Lloyd like most young men of his time served in the Second World War. He served in the Hygiene Section and was in Italy and Germany.


After the war Lloyd worked as a public health inspector for the Toronto Department of Public Health until 1952 when he moved to the St. Catharines Lincoln Health Unit. In 1957 Lloyd moved to Stratford, Ontario and started work for the City of Stratford Health Department. Lloyd and his wife Muriel raised their three children in Stratford. Lloyd even helped establish the district health unit and became the first Director of the Perth District Health Unit. During those times Lloyd use to take his son with him on the job. Those on-the-job experiences influenced Dave to become a public health inspector as well.

Lloyd was a member for the CIPHI executive council for many years and was president of the Ontario Branch from 1965 to 1966. Lloyd's other achievements include being the Regional Consultant for the Ontario Department of Health from 1972 to 1973, obtaining a Bachelor of Arts degree from Waterloo Lutheran University in 1973, and for 10 years being the Environmental Health Coordinator of the Nursing Home Inspection Service section of the Ministry of Health until 1983.

When you ask what made him want to go to work, Lloyd will tell you: "Besides the absolute necessity of having to make income, I found the day ahead always promised something of interest."

Now retired at 98 years young, Lloyd currently lives in Richmond Hill and is interested in family and physical fitness. He is an active member of the public speaking group in his retirement home.

Board of Certification Update

Student membership

Effective January 1st, 2016, the Board will require every applicant for BOC examination to be a current student CIPHI member. The objective of this initiative is to expose students to the rewards and benefits of membership in the hope that they will continue to be members for life.

BOC fees

Effective January 1, 2016 the examination fees will be increased from the current \$750 dollars to \$850 to reflect the increased costs of holding the exam.

<u>Exam</u>

This is the third October in a row where we were able to hold a one day BOC exam in Ontario. The October 2015 exam was also the largest one day exam involving 22 panels and 66 examiners. The one day exam ensures all students are measured using the same questions, as well as resulting in significant cost savings for the BOC (exam room, accommodations, mileage and meals).

2015 Examiners

In 2015 a total of 113 applicants applied to become a BOC Examiner. A total of 78 were selected to be examiners. Some of the benefits of being an examiner are:

- Earning CIPHI Professional Development Hours
- Helping to keep knowledge current
- Advancing the profession
- Experiencing increased networking opportunities
- Enhance the student practicum program

To qualify as a BOC examiner in Ontario you must:

- be a current regular member of CIPHI,
- have at least 5 years certified experience
- submit an annual BOC Examiner Application

Infectious Disease Working Group Update

As of March 2016 the membership includes the following individuals:

The latter part of 2015 saw significant working group membership changes. These changes created some difficulty in maintaining momentum for the following two initiatives identified in the 2015 work plan.

- An advocacy letter to the Minister of Health was prepared, regarding two requests. First, revisions to the Infection Prevention and Control Best Practices for Personal Services Settings and second, the development of a Personal Services Settings Regulation under the Health Protection and Promotion Act
- 2) A resource education video in the primary stages of development on Personal Services Settings. This was to be an educational resource for all PHIs. An educational tool was identified by CIPHI members through a needs assessment survey conducted by the working group in 2014/15.

In summary, project (1) was completed in draft form in June 2015 but later appeared unnecessary as there was some evidence to suggest that a working group facilitated by Public Health Ontario in collaboration with the Ministry of Health and Long Term Care were set to undertake revision of the Best Practice document.

Project (2) was re-discussed and the current working group came to the consensus that this was large undertaking given the current instability of the IDWG. The group discussed reviewing the current learning tool developed by Toronto Public Health over a decade ago and making some modifications with TPH's endorsement and support. The IDWG will review how the tool would reach CIPHI members at a later date. It was agreed that this was a more manageable initiative and would meet the needs of members and not be greatly affected by the pending revision of the Best Practice document.

The following are the IDWG initiatives for 2016.

- To build membership capacity and stability for the IDWG
- Update the CIPHI Personal Services Setting Fact sheets
- Four members will continue their advocacy and participation with the Personal Services Setting-Health Unit-Working Group (PSSHUWG). This group is revising the PSS Best Practice document. A preliminary document is anticipated by March 2016. This draft document will be circulated to all PHUs and stake holders for feedback.
 - An opportunity may exist for the IDWG to facilitate development of tools to support the new best practice document; ongoing assessment and discussion with the PSSPHUWG will continue.
- Review TPH's PSS teaching tool for PHIs and have a draft for priority modules.

Food Safety Working Group Update

The Food Safety Working Group has been steadily building a keen presence within the Province over the last year, providing feedback and review to numerous documents and initiatives. With a team of five members, the FSWG shared thoughts and insight on the review of O. Reg. 562 Food Premises Regulation, Bill 45 - Making Healthier Choices Act, and other current food safety initiatives. Presently, the FSWG is aiding the Central East Student Nutrition Program in crafting documents that will make transport of food to a new salad bar program in schools (sponsored by Farm to Cafeteria Canada and Sustain Ontario) a safe endeavour. This new salad bar program was reviewed by the FSWG, and feedback was given to the Ontario Edible Education Network, who is working in partnership with Farm to Cafeteria Canada and Sustain Ontario on this initiative.

Michelle Martin continued her work with the Guelph Food Safety Seminars, helping stage their symposium "Microbes, Memories, and Mansel: A Symposium in Honour of Professor Mansel Griffiths" on October 21, 2015. In November, Michelle hosted Ken Diplock, CPHI© and Dr. Shannon Majowicz as they presented a seminar for the GFSS on "Food Safety Education Needs of Ontario High School Students" on behalf of CIPHI.
